

STUDIO A MEMBER and PARENT CONTRACT
For
THE TALE OF THE NUTCRACKER 2022-23
Performance Dates: DEC 9th-10th
Dress Rehearsal the week of Nutcracker DATES DEC 6-8th

This document signifies an agreement between Studio A Dance Conservatory and _____ and his/her parents, hereinafter referred to as **NUTCRACKER COMPANY MEMBER and PARENTS**. It is understood that all matters related to training and performing will be under the direction of the Artistic Director; all matters related to operating the organization will be under the direction of STUDIO A DANCE CONSERVATORY.

SADC agrees to provide the following:

1. Formal instruction according to a schedule recommended by the Artistic Director and approved by director including classes, choreographic sessions and rehearsals, all under the supervision of the Artistic Director and Rehearsal Mistress.
2. Costuming production and designing.
3. Production aspects of the performance.
4. Accident and liability insurance for activities associated with training, rehearsing and performing.
5. Administrative support for students in their school environment (obtaining excused absences, verifying participation for service requirements, etc.)

THE COMPANY MEMBER and PARENTS agree to provide the following:

6. Non-Refundable Performance fee of \$250.00 for EVERY dancer. This payment is due in full by August 1st, 2022. This fee includes rehearsal hours spent with children, performance and dress rehearsal staging time. Non-payment of the performance fee renders a dancer ineligible for participation in *The Tale of the Nutcracker*.
7. Recognition of the Artistic Director as the responsible party for disciplinary policy and enforcement.
8. Compliance with NUTCRACKER COMPANY RULES (see studio policy online).
9. Appropriate dance attire, shoes and hair (see studio policy online).
10. Necessary performance supplies.
11. A current medical release and information form.
12. Advance written notice to the Artistic Director for ANY absence. Written excuse form is enclosed. If a dancer is sick, you must call the Artistic Director as soon as possible.
13. Cooperation with the NUTCRACKER COMPANY in planning for volunteer involvement in all activities.

14. I hereby give the COMPANY authorization to use any appropriate pictures that are taken of my child by an authorized member of the staff for use in publications and publicity material. Any pictures taken by our staff of the rehearsals or performances will not identify any children by name but will be for sale to parents and participants through www.four19photography.com.

This contract is in effect for Studio A Dance Conservatory production of The Tale of *The Nutcracker*, beginning July 21st, 2022 and ending May 30th, 2023. Upon signing this agreement you plan to follow all the rules and regulations. Rules of the studio can be found on studio website, www.sadanceconservatory.com. You understand and agree to all costume/tights/ and company dance fees.

A Costume meeting and Costume Check DATE will be posted by Sept 5th! We will answer all costuming needs/questions at this time!

Miss Anna likes to reuse old recital costumes- and keep costumes from previous Nutcracker performances to eliminate expenses for dancers!

Solo - or principal rolls- prices will vary based on needs

Snow- Any dancer cast in this- \$85

All NEW costumes you might need (candies, dolls, soldiers, mice, mother ginger, party scene) - Child Size \$75 and Adult Size \$85

ALL dancers will pay a \$15 prop fee (this is to help build the toymaker's work shop!!!) THIS IS DUE OCTOBER 1st, 2022
